3. 議決権行使結果の概況 (国内株式)

2020年1-3月期に開催された株主総会では、303社を対象に議決権行使を行いました。行使議案数では会社提案2,887議案、株主提案9議案でした。会社提案に対する反対率は14.3% (前年同期11.5%)、株主提案の反対率は77.8% (同83.3%) でした。

取締役の選解任の議案では、不祥事に対する有責性が懸念される、資本コストに照らしてROEが長期にわたり低水準にある、取締役会の独立性が乏しい、取締役会の構成において規模が過大である、社内取締役を増員する理由が明確ではない、保有株式の額が純資産の相当部分を占める、買収防衛策を導入・継続ないしは株主総会の決議とせず取締役会で導入・更新している場合は、原則として代表取締役の選任に反対しました。また独立性が十分でない場合や取締役会等への出席率が低い社外取締役の選任に反対しました。

監査役の選解任の議案では、独立性が十分でない社外監査役の選任に反対したほか、独立性の十分な監査役が半数に満たない場合、これに加えて社内監査役の選任に反対しました。

役員報酬議案では、監査役への賞与支給に反対しました。また、ストックオプション付与に関する議案においては、付与対象者に経営のモニタリングが期待される社外取締役が含まれる、1円オプションの権利行使の付与が退職後となっていない、金額過多で判断に値する情報開示が不十分である場合に反対しました。

退任役員の退職慰労金の支給では、金額開示が不十分で議案の賛否に関する判断が難しい場合、支給対象者に社外取締役、監査等委員、監査役が含まれている場合に反対したことから反対率が高くなりました。

買収防衛策の導入・更新については、個別に検討し、株主利益に資する十分な理由が認められない場合は反対しました。当社は対話を通じて、継続的に企業側に必要性の明確ではない買収防衛策の廃止を促しています。当四半期においては、東芝機械の買収防衛策の導入の議案に賛成しております。有事の買収防衛策の導入であることから、個別の状況をエンゲージメントにおいて確認し、必要性について議決権行使委員会において検討した上で、長期的な企業価値向上に資する観点から、会社提案を支持しました。

定款に関する議案においては、剰余金の配当等を取締役会の決議により行うことを可能とする議案、役付取締役の規定の変更、取締役会の定員増枠の議案に反対しました。

株主提案は、長期的な株主利益の増大につながるかどうかの観点から精査した上で、議案の妥当性を個別に判断します。当四半期は、帝国繊維において、増配と自己株式の取得に関する株主提案に賛成しました。同社が保有する現預金や保有株式を考慮すれば財務健全性を損なうことなく実施できると判断しました。
